Framework

- Co-financed under the European Regional Development Fund 2007-2013
- One of the four trans-national Objective 3 (European Territorial Cooperation) programmes
- Defined as an “exchange and learning programme for cities contributing to the ‘*Regions For Economic Change*’ initiative”
- Involvement of more and new partners



From URBACT

- Part of the URBAN II Community Initiative
- Special focus on URBAN II related issues:
Social cohesion and urban regeneration
- Strictly limited to URBAN and UPP cities
- EU 15 (- LUX)
- 18 Mio. €ERDF

to URBACT II

- Part of the Structural Funds Objective (3) „Territorial Cooperation“
- Broader focus on Cohesion policy themes:
Urban related cohesion themes + Lisbon/Gothenburg strategy actions
- No further participation limits for cities
- EU 27 + NO and CH
- 53 Mio. €ERDF



Programme objective

To improve the effectiveness of sustainable integrated urban development policies in Europe with a view to implementing the Lisbon-Gothenburg Strategy

- Exchange of experience and impact on urban development policies
- Dissemination of best practice and knowledge transfer
- Guidance for the creation and implementation of action plans on sustainable development (Structural Funds OPs)



URBACT II and *Regions for Economic Change*

URBACT II will be one of the two implementation programmes for the *Regions for Economic Change* initiative – for testing best practice for economic modernisation and increased competitiveness

- Defined key themes for economic modernization
- Bridge between the network programmes and the mainstream programmes to ensure that the outcome of the networks activities will result in actions plans
- Enhanced communication effort

- Strategic policies at city level with regard to ICT.
- Access to ICT for all citizens and for disadvantaged groups suffering from the effects of the digital divide
- ICT and employment policies (retraining workers in cities, setting up programmes for ongoing training)
- Centres of Excellence linked to the knowledge economy
- Partnerships (between cities, between cities and private concerns, cities and universities) in order to promote innovation and an entrepreneurial spirit.

- Targeted support to areas and groups at risk of exclusion to adapt to change and gain access to job in the growing parts of the urban economy

- Tackling the issue of territorial governance
- Co-ordinating land use policies and Structural and Cohesion Fund investments between urban areas, rural areas, the region and the national level to manage urban sprawl.
- Initiatives to make urban areas and city centres attractive places to live
- Enlarging networking of cities to networks of clusters to reach a critical size and elaborate common strategies
- Exploring the use of partnerships and other decentralized methods of governance for providing more responsive and effective solutions to urban problems.

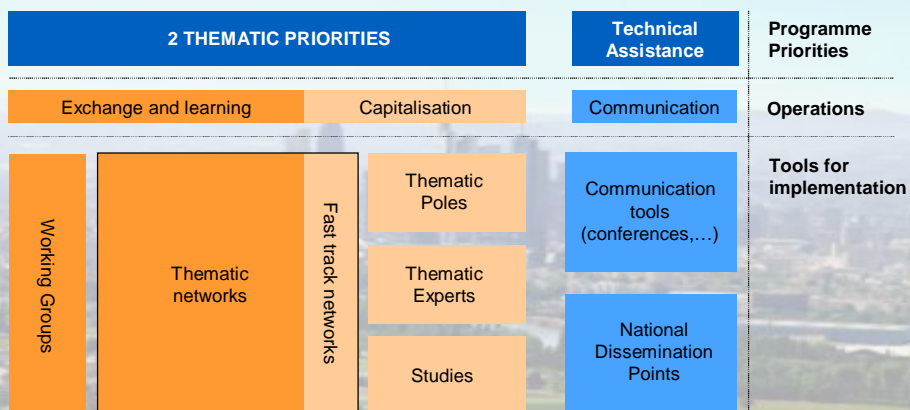

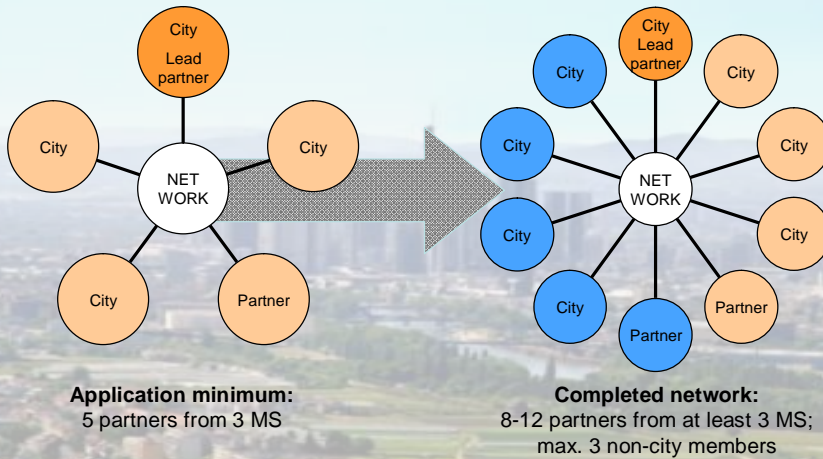


Thematic networks

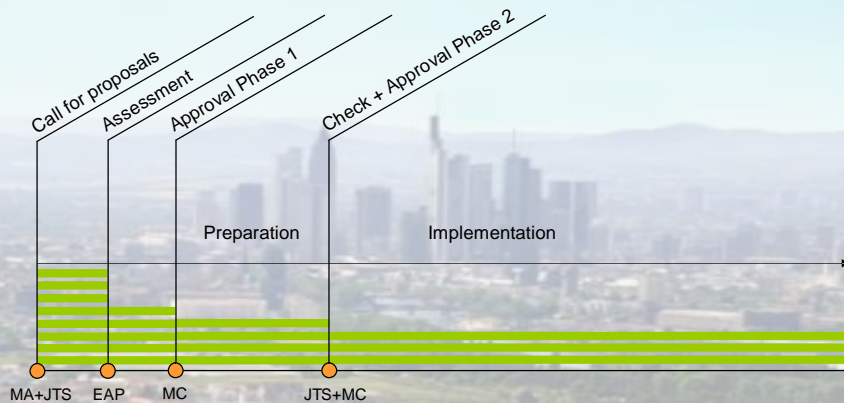
- Main instrument for the exchange between cities
- Established around the themes listed in the OP
- Two calls for proposals: 2007 and 2010
- In total 46 networks planned
- Fast track networks are thematic networks (active participation of the Commission services + implementation of Local Action Plans within OPs)
- Local Support Groups in all networks (involvement of elected local representatives)
- Thematic Experts (to guide and follow the process)

JTS: Joint Technical Secretariat – MA: Managing Authority – EAP: External Assessment Panel – MC: Monitoring Committee



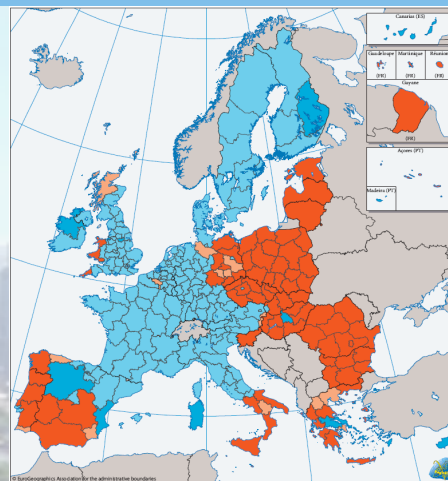
Beneficiaries

- Cities, municipalities, organised agglomerations
 - + Regional and national authorities
 - + Universities and research centers
 - + Private partners and associations (limited)
- No size limit for cities
- EU-27 plus Norway and Switzerland



Co-financing

- Priorities 1+2
 - 70% ERDF for cities in Competitiveness and Employment regions
 - 80% ERDF for cities in Convergence regions
- Priority 3
 - Co-financing ERDF - national ex-ante contributions
